### Meeting Notes

### I. <u>Welcome and Overview</u>

- a. This is our 3<sup>rd</sup> Task Force Meeting
  - i. First 2 meetings centered on collecting/analyzing data
  - ii. At  $2^{nd}$  meeting (2/2/21), 3 issues came to the surface:
    - 1. Food Insecurity
    - 2. Income Insecurity
    - 3. Housing Insecurity
  - iii. Most participant energy is around housing (repair, weatherization, etc.). Held deep dive discussion on housing on 3/2.
  - iv. Today will be hearing presentations about models, opportunities, resources that could support a project focused on housing.

# II. <u>City of Eastport – Updates</u>

- a. Eastport applied for an Island Institute Fellow to work on housing assessment, refining needs, public outreach, and liaison with this group.
  - i. Decision should be made by June.
  - ii. If accepted, the Fellow would start in September for a 2-year commitment.

# III. <u>Presentations</u>

a. ORPC & Island Institute

# i. John Ferland, Ocean Renewable Power Company

- 1. John is a member of M-DASH Eastport task force, specially to assist with energy discussion as it relates to housing.
- 2. ORPC develops underwater power systems; Eastport has long been product development center and test site. Has worked closing with the community, contractors, marine monitoring systems, etc.
- 3. Developed expertise in microgrid operation. Looking to create more of a commercial project in Eastport with this kind of project in mind.
- 4. Recently collaborated with the Island Institute to assist Eastport in applying for funding program to get assistance in developing a community energy plan.

# ii. Suzanne MacDonald & Emma Wendt, Island Institute

- 1. Island Institute has worked on affordable housing and reducing energy costs for Maine's island and coastal communities in various ways.

b. Efficiency Maine

#### i. Bridget Gifford, Program Manager

- 1. Goal of Efficiency Maine is to get better energy efficiency for everyone in Maine. Includes enhanced incentives to low- and moderate-income Mainers.

#### IV. <u>Questions/Discussion</u>

- a. For Island Institute
  - i. How to calculate "energy burden"?
    - 1. Annual spend on energy / income. There are national and state figures available, but that's a great idea to try to get more specific data.
    - Island Institute calculated energy burden by county in Maine a few years ago and mapped it - you can find it on page 11 of this report: <u>https://www.islandinstitute.org/wp-content/uploads/2021/03/Bridging-the-</u><u>Rural-Efficiency-Gap-final-report.pdf</u>
  - ii. When Island Institute did weatherization week projects on islands, how was it paid for?
    - 1. Island Institute would put in for a bit of total cost (e.g.\$50) and covered cost of getting contractors to island (travel; barges; lodging; etc.)
    - 2. For vast majority of jobs, about \$200 co-pay for residents.
    - 3. Doing this with communities was crucial because they found ways for those who could not cover it, to get it done.
    - 4. USDA is another resource for housing repair and rehabilitation.
    - 5. Very helpful to have someone available to patch together for homeowners how to pay for this.
    - 6. Having community-wide program helps normalize the work and gets everyone excited about participating.
- b. For Efficiency Maine
  - i. Efficiency Maine is not really getting resources to Eastport. Why?
    - 1. Need to spread the word more?
    - 2. New models of delivery? (e.g. Weatherization Week collective purchase model that Suzanne talked about.
    - 3. Challenge with installers?
      - a. Yes, especially for low- and moderate-income program.
      - Efficiency Maine does have specific partnerships with plumbers around ME, only about 21 in the state, though. They bundle whatever we need (eg 8 projects) to get them to go out to a particular area.
    - 4. Could you work with Community Colleges to incorporate training work into curriculum for interns etc.?
  - ii. What is total cost, if rebate for heat pump is \$2000?
    - Overall costs for typical installation in low-income program is a unit of about 15,000 BTU and total cost of around \$3500. Low end is about \$3100. So, co-pay is still substantial.

- iii. Does Efficiency Maine work with senior housing developments?
  - 1. For heat pumps, we are focused on single family homes.
  - 2. For other multifamily tenant programs: we do not have large low-income commercial offering, depends on type of facility they are living in.
- c. For Downeast Community Partners (Dale Basher)
  - i. Is Downeast Community Partners (Community Action Agency) doing any weatherization program and/or heat pumps for LIHEAP families?
    - 1. Yes working on both with Maine Housing
      - a. Weatherization Assistance Program anyone LIHEAP is eligible but we have 40% walk away from houses that we visit because criteria are so strict. Often, the people who need it the most don't get it because of rigid regulations.
      - b. Also do Indoor air quality testing.
      - c. Heat Pump program: Just recently rolled out heat pump program. Have done 17 so far this year; plan to do 100 heat pumps this year for LIHEAP families.
      - d. We do have a few people in Eastport identified for installation.
      - e. Still doing intake for 30 more.
      - f. Hoping to get more funding if we can quickly install the 100 we have.
      - g. Also working on solar assistance. Want to create solar array to power the heat pumps.
  - ii. DCP also has an energy savings solar project in Franklin, ME; producing energy credits.
  - iii. DCP also has pilot project with Maine Seacoast Mission: using volunteers to fix homes up to a level that DCP can then come in to weatherize. Eliminating "deferrals" of services. Could we figure out how to get them to come to Eastport?

# V. <u>Next Steps</u>

- a. Consensus: Housing Insecurity will be the first priority area for action planning.
