

MCOA tracked over 250 bills during the first Regular Session of the 131st Maine Legislature related to aging and issues impacting older Mainers. Some bills didn't pass muster, many good bills were carried over for various reasons and many more were enacted and will become law. Below is an overview of enacted bills and bills that were carried over.

Biennial Budget Recap: In addition to the Services Budget passed earlier in the session, the second portion of the Governor's Biennial Budget was enacted in July. Beyond the specific bills that were incorporated into this package, here are the investments that impact older Mainers.

- \$15m to increase eligibility for the Medicare Savings Program and remove asset tests for this program and Drugs for Maine's Elderly
- \$5.5m for Meals on Wheels Delivery

- \$2m to create a Food Security Hub addressing the needs of food insecure people
- \$1m for Maine's Area Agencies on Aging to enhance the state's Aging and Disability Resource Centers
- Funding to support the Elder Justice Roadmap including:
 - \$40k for the Elder Victims Restitution Fund
 - o \$1.4m for the continuation of the Elder Services Connection Project, and
 - o \$175k for continued funding of the Purchased Goods and Services Pilot Program
- \$19.8m toward a one-time 3% cost-of-living adjustment for Maine State Retirees
- \$15m in one-time funding for low-income energy assistance
- Increases the annual income tax pension deduction by tying the deduction amount to the maximum Social Security benefit (which is indexed to inflation)
- Appropriates funding to significantly increase eligibility for the State Property Tax Deferral Program and the Senior Property Tax Fairness Credit
- Establishes the Housing First Program to address needs of those facing chronic homelessness
- \$70m for construction of affordable housing via the Rural Affordable Rental Housing Program and the Low-Income Housing Tax Credit Program
- \$12m in one-time funding to the Emergency Housing Relief Fund
- \$4m in one-time state funding to legal aid providers to represent tenants in evictions
- \$4m increase for Civic Legal Services Fund
- \$25m to establish the Paid Family Medical Leave Insurance Fund
